

THE PRINCETON REVIEW SUMMER 2022 COLLEGE ADMINISTRATOR SURVEY

The Princeton Review[®] conducted the Summer 2022 College Administrator Survey from July 1 to 26, 2022. The 15-question survey was sent to college administrators at 656 institutions including the schools profiled in the company's book, *The Best 388 Colleges: 2023 Edition* (August 23, 2022), and its <u>2023 Best Regional Colleges</u> website feature.

The survey asked administrators about their school's fall instructional modalities, COVID protocols, admission test policies, enrollment forecasts, and other current topics. It asked them to rank four issues based on which they expect will be the key concerns among their school's students, and which they expect to be the key concerns among their fellow administrators in the 2022–23 school year.

This report shows each survey question, answer choice, and the percentage of respondents choosing each answer. Findings are based on responses from administrators at 182 institutions and reported by: respondents overall, school type (private/public) and school region (NE, SE, MW, SW, and NW).

15) (Optional) What would you like us to know about your institution as this school year begins? Please describe any programs, protocols, or statistics we might cite in reporting our survey findings.

Below are notes from 10 administrators that submitted information about their schools specifically in response to topics on the survey.

ON COVID PROTOCOLS

While masking at our university is currently optional, with the exception of our campus medical facilities and transportation (where masks are still required), we will continue to monitor the evolution of this virus and make appropriate determinations regarding masking moving forward. <u>American University (DC)</u>

Although we did not require faculty and staff to be vaccinated (mandates are against state law), we had 100-percent vaccination status of full-time faculty and over 90-percent of staff. The College of Idaho (Caldwell, ID)

We will start the 2022 academic year fully in-person. All new and returning students will be tested upon their arrival on campus. Specific masking protocols for the fall will be determined closer to the start of fall term, based on the status of the virus on- and off-campus at that time. Lawrence University (Appleton, WI)

Our answers to the COVID questions would have been different had we filled out the survey a few weeks ago. For all institutions of higher education in the state of Illinois, private or public, until mid-July 2022 the state had mandated full vaccination, along with mandatory testing for students, faculty and staff who requested exemptions from vaccination. If COVID worsens in Illinois appreciably, the state could easily reinstall these mandates.

North Central College (Naperville, IL)

We do encourage everyone to be up to date on COVID vaccinations but only require either the primary dose of the vaccine or an approved exemption. We do not require social distancing of any campus community member and face coverings are optional for all campus community members. We do not plan to require testing.

St. Edward's University (Austin, TX)

In alignment with SUNY guidelines, students must complete their primary vaccination series; booster shots will be strongly encouraged but not required. Employee health requirements are set by the union CBA and are statewide. The university will strongly encourage all employees to

be up to date on vaccinations including boosters....Our university health and safety committee and leadership will continue to closely monitor the pandemic and adjust our health protocols as needed in the academic year.

ON ENROLLMENT FOR FALL 2022

Strong enrollment continues. After a record-breaking application season (35,000+ applications this year, up about 5% from 2020), UD expects to welcome its largest incoming class this fall. About 4,800 admitted students have deposited currently (up 18% from 2020). We see this as a testament to UD's strong value proposition, especially in light of broad demographic trends and other challenges facing higher education.
